regarding individual constituents.

Thus, the blue latex gloves **321C-70.30 CIQ MAGNO 70 (Blue)** according to the sample material submitted may be used safely in the food industry during the preparation and handling of food. They may stand in direct contact with all types of food for a short period of time.

The maximum ratio of the food contact surface of the gloves and the amount of food shall not exceed 8.4 dm² per 5 kg food. This is equivalent to a contact of the palm and back of both hands including fingers with 5 kg food.

This certificate of compliance represents the latest technical standard and is based on the certificate of compliance no. 44010 U 17 of 24 January 2017 in connection with a new partial examination of the product.

It has a validity of 2 years and consists of 4 pages.
